Sub: Extension of provisional temporary approval of affiliation to Institute of Law, Shri Jagdishprasad Jhabarmal Tibrewala University, Jhunjhunu, Rajasthan for three year LL.B as well as five year BA LL.B law courses for the academic year 2018-2019.

Sir,

This is with reference to above mentioned subject regarding extension of provisional approval of affiliation Institute of Law, Shri Jagdishprasad Jhabarmal Tibrewala University, Jhunjhunu, Rajasthan which has already applied for extension of approval of affiliation for the academic year 2018-19 and inspection of the Bar Council of India is pending.

The matter relating to colleges similarly placed were considered by the Bar Council of India at its meeting held on 25<sup>th</sup> & 26<sup>th</sup> May 2018. The resolution passed was as follows:

“RESOLVED that colleges whose inspection fee has been deposited, application for extension of approval of affiliation is pending, no inspection could be done or the inspection has been done, but inspection report could not be placed before, the Legal Education Committee or the Standing Committee for its consideration, then such colleges may continue to admit students only for the academic year 2018-2019. This will apply only in case where affiliation has been granted by the University which of course shall be subject to the inspection to be made by the Bar Council of India subsequently.”



Since your university has given affiliation for the year 2018-2019, you are requested to allow Institute of Law, Shri Jagdishprasad Jhabarmal Tibrewala University, Jhunjhunu, Rajasthan to admit students in three year LL.B as well as five year BA LL.B law courses with existing sections for the academic year 2018-2019.

This is for your information and necessary action.

**Note - Your University is requested to kindly verify the authenticity of the attached affiliation order submitted by the college and revert back to the Bar Council of India through e - mail as soon as possible.**


**Note - (1) That w.e.f 21.05.2016 the inspection fee for LL.B three year and five year regular course is Rs. 3 lacs for each course and for the Honours course it is Rs. 5 lacs, while the application fee is Rs. 50,000/- and the guarantee amount is Rs. 5 lacs.**

**Note - (2) your college is requested to pay Rs.5000/- towards pending application fee for 2016.**


